

Information clause

Pursuant to Art. 13 of the Regulation of the European Parliament and of the Council (EU) of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC, hereinafter referred to as "GDPR "And in connection with the acquisition of your personal data (name, surname, telephone number, e-mail address), we hereby inform that:

The administrator of your personal data is Vocaly Pro Sp. z o.o., ul. Garbarska 16, 20-340 Lublin, e-mail: info@vocalypro.com (hereinafter referred to as the "**Administrator**")

Personal data will be processed for the purpose of:

- A. Provision of services by the Administrator by electronic means within the meaning of the Act of 18 July 2002 on the provision of electronic services (i.e. Journal of Laws of 2017, item 1219 as amended), consisting in sending a newsletter, commercial and marketing information by the Administrator - based on the consent granted (in accordance with Article 6 (1) (a) of the GDPR),
- B. conducting marketing and promotional activities in the form of preparing and presenting the offer of Vocaly Pro sp.z o.o. and cooperating companies - based on the consent granted (in accordance with Article 6 (1) (a) of the GDPR).

Withdrawal of consent does not affect the lawfulness of the processing of your personal data, which was made on the basis of consent before its withdrawal.

You have the right to access the data and rectify it, delete or limit processing, the right to object to the processing, the right to transfer data, as well as the right to withdraw consent to processing at any time. You have the right to lodge a complaint with the supervisory body - i.e. the President of the Personal Data Protection Office.

The data provided by you may be shared with third parties. The recipients of the data will be the business partners of Vocaly Pro Sp. z o.o., thanks to which the Administrator may present an offer (if you consent to the processing of data for the marketing purposes described above), as well as institutions authorized by law, to the extent resulting from legal provisions.

The data provided by you may be subject to automated decision making, including in the form of profiling. These activities are aimed at sending personalized marketing content to you, as part of the Administrator's legitimate interest, which is to get to know users and offer them information tailored to individual preferences. You can object to automated decision making, including profiling, at any time.

The data controller will not transfer personal data to a third country or international organizations.

Personal data will be stored for a period of 5 years, counting from the beginning of the year following the year in which consent to the processing of personal data was given, or until you withdraw your consent to data processing or raise an objection.

The administrator makes every effort to ensure all means of physical, technical and organizational protection of personal data against accidental or deliberate destruction, loss, alteration, unauthorized disclosure, use or access, in accordance with all applicable regulations.

Providing your personal data is voluntary, but required to send the newsletter and marketing offer, and failure to provide the data will result in the inability to receive this information from the Administrator.
